**REGULATION 11 – PRE-APPLICATION PUBLICITY UNDER SECTION 48 OF THE PLANNING ACT

I write on behalf of Multifuel Energy Ltd (MEL) in accordance with Regulation 11 'Pre-application publicity under S.48 of the Planning Act 2008 (duty to publicise)'.

I confirm that MEL (the Applicant) intends to apply to the Secretary of State (SoS) under S.37 of the Planning Act 2008 for a Development Consent Order (DCO) for the proposed Ferrybridge Multifuel 2 (FM2) Power Station located within the Ferrybridge Power Station site, Stranglands Lane, Knottingley, West Yorkshire.

The Proposed Application is an application for Environmental Impact Assessment (EIA) development and therefore, in accordance with Regulation 11, the Applicant is required, at the same time as publishing notice of the proposed application under S.48(1) of the Planning Act 2008, to send a copy of that notice to the consultation bodies and to any person notified to the Applicant by the SoS under Regulation 9(1)(c).

Your organisation has been identified as one of the consultation bodies and therefore a copy of the S.48 Notice that is to be published in a national newspaper (The Independent), The London Gazette and local newspapers circulating in the vicinity of the land to which the Proposed Application relates (The Yorkshire Post, The Selby Times and The Castleford and Pontefract Express) is attached to this letter.

The Notice will be published in The Independent and The London Gazette on 1 November 2013, in The Yorkshire Post on 1 and 8 November 2013 and The Selby Times and Castleford and Pontefract Express on 31 October and 7 November 2013.
